## RESOLUTION NUMBER R- 290811 ADOPTED ON 0CT 0 5 1998

WHEREAS, the project consists of five actions 1) extension of Nobel Drive easterly from its existing terminus at Shoreline Drive to a connection with Miramar Road; 2) the construction of a new half diamond interchange at Nobel Drive/I-805; 3) improvements at the existing La Jolla Village Drive/Miramar Road/I-805 interchanges; 4) improvements to the existing Governor Drive/I-805 interchange; and 5) widening of Miramar Road; and

WHEREAS, the purpose of this project is to relieve existing and projected traffic congestion for I-805 and local streets in the project area; and

WHEREAS, the project is proposed jointly by the City of San Diego, the State of California Department of Transportation (CalTrans) and FHWA the federal agency responsible for overseeing the National Highway System Interstates, and

WHEREAS, the City of San Diego has completed and distributed for public review an Environmental Impact Report/Environmental Impact Statement No. DEP 91-0397 addressing two alternative alignments identified as Alternative "A" and Alternative "B" for the Nobel Drive/I-805 interchange project, as well as the extension of Nobel Drive; construction of a new half diamond interchange; the La Jolla Village Drive/Miramar Road/I-805 interchange; improvements to the existing Governor Drive/I-805 and widening Miramar Road; and

WHEREAS, the matter of choosing an alignment for the Nobel Drive/I-805 interchange is being set for public hearing to be conducted by the Council of the City of San Diego; and

WHEREAS, the Council of the City of San Diego considered the issues discussed in the Environmental Impact Report/Environmental Impact Statement DEP 91-0397 and all evidence and public testimony presented at the hearing, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that after careful consideration of the two optional alignments (Alternative A and B) for the Nobel Drive/I-805 interchange discussed in the Environmental Impact Report/Environmental Impact Statement DEP 91-0397, it adopts and implements Alternative B.

BE IT FURTHER RESOLVED, that it directs the City to proceed with Alternative B for the Nobel Drive Extension as well as the extension of Nobel Drive, construction of a new half diamond interchange, the La Jolla Village Drive/Miramar Road I-805 interchange improvements to existing Governor Drive/I-805 and widening Miramar Road, as described in the Environmental Impact Report/Environmental Impact Statement No. DEP 91-0397.
