BE IT RESOLVED by the Council of The City of San Diego that a Conflict of Interest Code for the Qualcomm Stadium Advisory Board is hereby adopted, consisting of standard language embodied in 2 California Code of Regulations section 18730 and any amendments to that regulation duly adopted by the FPPC, Appendix A showing duties of board members, and Appendix B showing the disclosure categories.

BE IT FURTHER RESOLVED that a copy of the Qualcomm Stadium Advisory Board Conflict of Interest Code as adopted be placed on file with the Office of the City Clerk as

BE IT FURTHER RESOLVED that the members of the Qualcomm Stadium Advisory Board shall file their statements of economic interest with the City Clerk.

BE IT FURTHER RESOLVED that statements of economic interest filed by designated persons be retained by the Office of the City Clerk and be made available for public inspection and reproduction.

BE IT FURTHER RESOLVED that the Conflict of Interest Code for the Qualcomm Stadium Advisory Board become effective upon the date of adoption of this resolution.


