A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING A LOAN REPAYMENT FROM THE LINDA VISTA REDEVELOPMENT PROJECT, AMENDING THE FY 1999 BUDGET OF THE CDBG PROGRAM INCOME FUND TO ACCEPT THE PAYMENT, AND AUTHORIZING RELOAN TO THE SAN YSIDRO REDEVELOPMENT PROJECT.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That \$30,000 from Redevelopment Agency Fund 98501 be accepted, representing payment of interest on loans made by the City to the Agency in the Linda Vista Redevelopment

  Project.
- 2. That the City Auditor and Comptroller is authorized and directed to deposit and appropriate the above recited \$30,000 to Fund 18502, titled "Community Development Block Grant Fund" [CDBG Program Income Fund], and that the FY 1999 budget for the CDBG Program Income Fund 18502 be amended to include the \$30,000.
- 3. That the City Auditor and Comptroller is authorized and directed to transfer the above-recited \$30,000 from CDBG Program Income Fund 18502 to FY 1999 CDBG Fund 18534, and to disburse \$30,000 from Fund 18534 to the Redevelopment Agency for use in the San Ysidro Redevelopment Project Fund 98570.
- 4. That the Auditor and Comptroller is directed to record the above disbursement to the Agency as an interest-bearing loan, and such loan shall accrue interest as calculated by the City Auditor and Comptroller, to be repaid from tax increment or other revenues.

5. That in the event that the Agency issues bonds, notes, refunding bonds or other instruments of indebtedness of the Agency to carry out these redevelopment projects, then any indebtedness of the Agency to the City, including any interest accrued thereon, shall be deemed not to be a first pledge of tax increment allocation received by the Agency pursuant to California Health and Safety Code section 33670; and any indebtedness of the Agency to the City, including any interest accrued thereon shall be subordinate to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.
