

RESOLUTION NUMBER R- 290891

ADOPTED ON OCT 19 1998

WHEREAS, in Fiscal Year 1998, the City Council voted to appropriate FY 98 Community Development Block Grant (CDBG) funds for those projects recommended for funding by the individual Council offices; and

WHEREAS, the City Council authorized the City Manager to include said projects in the City's FY 98 CDBG Action Plan; and

WHEREAS, the Fourth Council District now wants to amend its recommendations for FY 98 CDBG funding; and

WHEREAS, such an amendment would require amending the FY 99 CDBG Action Plan and Budget; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the FY 98 Community Development Block Grant \$85,000 allocation for the Community Economic Development Association be canceled and that the funds be redistributed to the following projects:

\$50,000 Bayview Certified Development Corporation

\$15,000 Wall of Excellence

\$15,000 Street Lights (SEDC)


\$5,000 Reserve

2. That the FY 99 Community Development Block Grant Action Plan and Budget is hereby amended to include those projects and amounts.

3. That the San Diego Housing Commission be requested to administer the Bayview Certified Development Corporation allocation and that the Southeastern Economic Development Corporation administer the Street Light project on behalf of the City.

4. That the City Manager is hereby authorized to negotiate and execute agreements for the construction of the Wall of Excellence project.
