

RESOLUTION NUMBER R- 290967

ADOPTED ON NOV 24 1998

WHEREAS, the State of California has authorized the distribution of State Block Grants called "Citizens Options for Public Safety" (State COPS), first authorized in 1996 by Assembly Bill (AB) 3229, the purpose of which is to supplement the front line law enforcement resources of local jurisdictions throughout the State; and

WHEREAS, funding allocated to the San Diego Police Department is \$2,762, 515.99; and

WHEREAS, AB 3229 requires that the City Council appropriate these funds in accordance with the request of the Chief of Police; and

WHEREAS, the *approximate* allocation of the funds will be: Central Division Substation (\$1,280,000); and miscellaneous equipment, maintenance and upgrades, including vehicles, lab, communications, automation and safety items (\$1,483,000); and

WHEREAS, AB 3229 requires that the City set up a Supplemental Law Enforcement Services Fund to receive and expend these funds; NOW, THEREFORE,

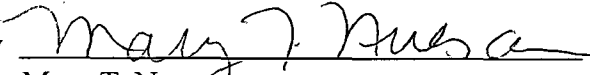
BE IT RESOLVED, by the Council of The City of San Diego, that the Chief of Police, on behalf of the City Manager, be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to apply for, accept and expend these grant funds from the State of California;

BE IT FURTHER RESOLVED, that the Council hereby authorizes the City Manager, via the Auditor and Comptroller, to set up a Supplemental Law Enforcement Services Fund, as required by the legislation, to receive and expend these funds;

BE IT FURTHER RESOLVED, that the Council hereby authorizes the City Manager to execute all aspects of program operation including any amendments and extensions thereof, and to certify that the City will comply with all applicable statutory or regulatory requirements related to the program;

BE IT FURTHER RESOLVED, that any resources received hereunder shall not be used to supplant expenditures controlled by this body.
