RESOLUTION NUMBER R- 291036 ADOPTED ON DEC 0 7 1998

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of public streets by City Council resolution where the portion of the street vacated is excess to the City's right-of-way needs and is no longer required for street or highway purposes, and

WHEREAS, on April 21, 1998, by Resolution No. R-289998, the City Council approved the vacation of Questor Place as shown on Exhibit "A" to R-289998 and conditioned the vacation upon the filing of a final map for Mission City, Tentative Map 96-0544 [Final Map Condition]; and

WHEREAS, based upon the findings below, the City Council is willing to vacate Questor Place without the requirement of the Final Map Condition; and

WHEREAS, the abutting property owner has requested the vacation of Questor Place to facilitate development of the site; and

WHEREAS, The City of San Diego and H.G. Fenton Material have entered into an Exchange Agreement dated November 14, 1997, on file in the office of the City Clerk as Document No. RR-289263-1, which in part addresses the vacation of Questor Place; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and


WHEREAS, in connection with the vacation, the City desires to reserve a certain easement; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the street either for the public street system, for which the right-of-way was originally acquired, or for any other public use of a like nature, that can be anticipated in that the right-of-way is not needed for public street, bikeway, or open space purposes; and
 - (b) the public will benefit from the vacation through improved utilization of land; and
- (c) the vacation is not inconsistent with the General Plan or an approved Community
 Plan; and
- (d) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Questor Place, located east of Old Quarry Road, as more particularly shown on Drawing No. 18854-B, on file in the office of the City Clerk as Document No. RR-291036, and Exhibit "A," which is by this reference incorporated herein and made a part hereof, is ordered vacated.
 - 2. That the Final Map Condition is not required for this vacation.
- 3. That The City of San Diego reserves and excepts the right, from vacation and abandonment, general utility easements, and rights of any public utility pursuant to any existing franchise or renewals thereof, at any time, or from time to time, to construct, maintain, operate, replace, remove, renew, and enlarge overhead or underground lines of pipe, conduits, cables, wires, poles, and other structures, equipment, and fixtures for the transportation and distribution of electrical or electronic energy and natural gas, and for incidental purposes including access to



protect the property from all hazards in, upon, over, and across the above-described portions of streets to be vacated and abandoned as indicated on Drawing No. 18854-B.

- 4. That this vacation shall not be effective unless and until all other conditions of the Exchange Agreement have been completed.
- 5. That the City Engineer shall advise the City Clerk of the completion of the conditions of the Exchange Agreement and the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.


