RESOLUTION ESTABLISHING AN UNDERGROUND
UTILITY DISTRICT TO BE KNOWN AND DENOMINATED
AS THE UNIVERSITY AVENUE (WASHINGTON STREET
TO THIRD AVENUE) UNDERGROUND UTILITY DISTRICT
AND AUTHORIZING THE EXPENDITURE OF FUNDS.

WHEREAS, by Resolution No. R- 290910, a public hearing was called for on December 8, 1998 at the hour of 10:00 a.m. in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, to determine whether the public health, safety, or general welfare requires the removal of poles, overhead wires, and associated structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within that certain area of the City of San Diego, including the described public rights-of-way, more particularly shown in the Legal Description attached as Exhibit A and incorporated herein, and as more particularly shown in Drawing No. 26985-D, entitled "UNIVERSITY AVENUE (WASHINGTON STREET TO THIRD AVENUE) UNDERGROUND UTILITY DISTRICT," copies of which are on file in the office of the City Clerk as Document RR- 290910; and

WHEREAS, notice of such hearing has been given by the City Clerk to all affected property owners as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and to the utilities concerned in the manner and for the time required by law; and

WHEREAS, such hearing has been duly and regularly held and all persons interested have been given an opportunity to be heard; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The City Council hereby finds and determines that the public health, safety, or general welfare require the removal of poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within the area set forth above and that pursuant to Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, the above described area is hereby declared to be an underground utility district in the City of San Diego, and the maps and document referred to above are hereby incorporated as a part of this resolution.


2. The City Council shall by subsequent resolution fix the date on which the property in the district must be ready to receive underground service, and shall by subsequent resolution order the removal of all poles, overhead wires, and associated overhead structures, and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service.

3. The City Clerk is hereby instructed to notify all affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and all affected utility companies of the adoption of this resolution within fifteen days after date of adoption. The City Clerk shall further notify affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code of the necessity that if they desire to continue to receive electric, communication, community antenna television or similar or associated service they shall provide at their own expense all necessary facility changes on their premises so as to receive underground service from the lines relocated underground of the supplying utility company subject to applicable rules, regulations, and tariffs of the respective utility company on file with the Public Utilities Commission of the State of California (as of the date of adoption of this resolution) and subject to all other

applicable requirements of State law and City ordinances. The Clerk's notification shall be made in the manner provided in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$30,000 from Annual Allocation - Undergrounding of City Utilities, CIP 37-028.0, Sublet 372909, TransNet Fund No. 30300, is hereby authorized, solely and exclusively to provide funds to administer the University Avenue (Washington Street to Third Avenue) Underground Utility District, pay for minor City Force work, replace existing street lights, and other related work.

**GENERAL BOUNDARY DESCRIPTION FOR THE
UNIVERSITY AVENUE
(WASHINGTON STREET TO THIRD AVENUE)
UNDERGROUND UTILITY DISTRICT**

The UNIVERSITY AVENUE (WASHINGTON STREET TO THIRD AVENUE) UNDERGROUND UTILITY DISTRICT shall be established to include the following described parcels:

Portion Lots 6,7,8 and 20 of BLOCK 65, Lots 9-19 of BLOCK 65, Lots 3 -22 of BLOCK 66, Portion lots 5 and lot 6-22 of BLOCK 67, Lots 6-18 of BLOCK 69, Portion lots 23 and 24 of BLOCK 76, Portion lot 3 and lots 1 and 2 of BLOCK 75, Lots 1,2,23 and 24 of BLOCK 74, Lots 1 and 2 of BLOCK 73 of ARNOLD & CHOATE'S PUEBLO LOT "B" ADDITION TO SAN DIEGO MAP NO. 334:

Portion lots 1-5 and lots 6-10 of BLOCK 68 of RE-SUBDIVISION BLOCK 68 ARNOLD AND CHOATE'S ADDITION MAP 1124:

Parcel 1 of DOVE HEIGHTS MAP 3788:

Portion lots 19,20 and lots 16,17,18 and 21 of BLOCK 5, Portion lot 15 of BLOCK 7 of FLORENCE HEIGHTS ADDITION MAP 892:

Lot 2 of BLOCK 3 of MAP OF PALM HEIGHTS MAP 1023:

Portion lots 1 and 2 of BLOCK 4 of MAP OF CLEVELAND HEIGHTS MAP 621:

Said district shall also include the following public rights-of-way:

UNIVERSITY AVENUE between the easterly line of IBIS STREET and the westerly line of THIRD AVENUE;

HAWK STREET between a line parallel to and 60 feet south of the southerly line of UNIVERSITY AVENUE and the southerly line of WASHINGTON STREET;

GOLDFINCH STREET between a line parallel to and 25 feet south of the southerly line of UNIVERSITY AVENUE and the southerly line of WASHINGTON STREET;

FALCON STREET between a line parallel to and 50 feet south of the southerly line of UNIVERSITY AVENUE and the southerly line of WASHINGTON STREET;

EAGLE STREET between a line parallel to and 25 feet south of the southerly line of UNIVERSITY AVENUE and a line parallel to and 175 feet north of the northerly line of UNIVERSITY AVENUE;

DOVE STREET between the southerly line of UNIVERSITY AVENUE and a line parallel to and 150 feet north of the northerly line of UNIVERSITY AVENUE;

ALBATROSS STREET between a line parallel to and 97 feet south of the southerly line of UNIVERSITY AVENUE and a line parallel to and 137 feet north of the northerly line of UNIVERSITY AVENUE;

FRONT STREET between a line parallel to and 70 feet south of the southerly line of UNIVERSITY AVENUE and the northerly line of UNIVERSITY AVENUE;

FIRST AVENUE between a line parallel to and 42 feet south of the southerly line of UNIVERSITY AVENUE and the northerly line of UNIVERSITY AVENUE;
