BE IT FURTHER RESOLVED, that the City Attorney and City Manager are directed to review the Operating Agreement between the City and SDDPC and to make recommendations to the City Council for changes to the Agreement to protect the City from any such awards in the future and to ensure full participation by the City in any claims made by or against SDDPC

which may adversely affect the City.
