SEC. 103.2102 Boundaries

The regulations of this Division shall apply in the Mission Valley Planned District which is within the boundaries of the Mission Valley Community Planning Area in the City of San Diego, California, designed in that certain Map No. C-884, and described in the boundary description filed in the Office of the City Clerk as Document No. OO-18506.

Section 2. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
