ORDINANCE NUMBER O- 18628 (NEW SERIES)

ADOPTED ON MAR 23 1999

AN ORDINANCE AMENDING ORDINANCE NO. O-18551 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1998-99 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-18551, TO EXEMPT FROM THE CLASSIFIED SERVICE THE POSITION OF PROGRAM MANAGER FOR THE POLICE FLEET IN THE POLICE DEPARTMENT.

WHEREAS, on February 4, 1999, the Civil Service Commission reviewed a request from the Police Chief, in his memo dated December 23, 1998 to the Civil Service Commission, to exempt a Program Manager (Police Fleet Manager) position from the classified service; and

WHEREAS, the Civil Service Commission commented unfavorably upon the request from the Police Chief to exempt the Program Manager (Police Fleet Manager) position from the classified service in its memo to the Mayor and Council dated February 11, 1999; and

WHEREAS, the Police Department considers the Police Fleet Manager as a critical position that possesses managerial and leadership skills in addition to knowledge and experience in the automotive/equipment industry, and therefore requests the position be exempt from the classified service; and

WHEREAS, it is necessary to amend the annual appropriation ordinance to exempt said position in the Police Department; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-18551, as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1998-99 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" be and the same is hereby amended by amending Document No. OO-18551, that pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented unfavorably upon by the Civil Service Commission as not meeting the Charter criterion for exemption from the classified service, and after having considered and reviewed the memorandum dated December 23, 1998 from the Police Chief to the Civil Service Commission and the report thereon from the Civil Service Commission to the Mayor and Council dated February 11, 1999, attached hereto as Attachments A and B, the position of Program Manager (Police Fleet Manger) in the Police Department be and is hereby exempted from the classified service and declared to be in the unclassified service of The City of San Diego.

Section 2. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 3. This ordinance is declared to take effect and be in force immediately upon its passage after two public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
