AN ORDINANCE AMENDING CHAPTER X, ARTICLE 3,
DIVISION 17, OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 103.1703 (CURRENT LANGUAGE)
RELATING TO THE SOUTHEAST SAN DIEGO PLANNED
DISTRICT APPLICABLE REGULATIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 3, Division 17, of the San Diego Municipal Code is amended by amending Section 103.1703, to read as follows:

SEC. 103.1703 Applicable Regulations

Permit may be extended in accordance with Section 111.1122. The Development Services Director shall notify the recognized community planning group with responsibility for the area where the project is proposed of any extension of time requests.

The Southeast Economic Development Corporation's Board and the recognized community planning group with responsibility for the area where the

project is proposed shall advise the City Council, Planning Commission and Development Services Director on matters of design review, as follows:

1. Prior to any action being taken on any discretionary permit for projects within the Southeast Community Planned District, copies of said permit shall be forwarded and reviewed by the Southeast Economic Development Corporation's Board and the recognized community planning group with responsibility for the area where the project is proposed.

2. and 3. [No change.]

4. The recognized community planning group with responsibility for the area where the project is proposed shall review discretionary permits in the manner established by Council Policy 600-24 which provides for community review of ongoing projects and plan implementation.




