

ORDINANCE NUMBER O- 18683 (O-2000-11)

ADOPTED ON SEP 14 1999

AN ORDINANCE EXTENDING THE TERMS OF THE NON-EXCLUSIVE SOLID WASTE FACILITY FRANCHISE AGREEMENTS OF ALLAN COMPANY, BDC SPECIAL WASTE, COAST WASTE MANAGEMENT, DEBRIS BOX, DEPENDABLE DISPOSAL, MOOR REFUSE, PACIFIC WASTE, RELIABLE WASTE, USA WASTE, WARE DISPOSAL, WASTE MANAGEMENT, AND AUTHORIZING THE CITY MANAGER TO EXECUTE NEW FRANCHISE AGREEMENTS WITH SAID FRANCHISES; AND EXTENDING THE TERM OF DOMINION DISPOSAL.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the Non-Exclusive Solid Waste Facility Franchise Agreements of the following franchises are hereby extended by one year to December 12, 2004 : Allan Company, BDC Special Waste, Coast Waste Management, Debris Box, Dependable Disposal, Moor Refuse, Pacific Waste, Reliable Waste, USA Waste, Ware Disposal, and Waste Management.

Section 2. That the City Manager is hereby authorized to execute new Non-Exclusive Solid Waste Facility Franchise Agreements with the following franchises, copies of the new agreements are on file in the Office of the City Clerk's office as follows:


Section 3. That the extension of the Non-Exclusive Solid Waste Facility Franchise Agreement with Dominion Disposal, by one year to December 12, 2004, a copy of said agreement is on file in the Office of the City Clerk as Document No. OO-18639, is hereby approved.

Section 4. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 5. This ordinance having been introduced and adopted by a two-thirds vote of the members of the Council shall take effect and be in force on the thirtieth day from and after its passage.
