AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A FIFTH AMENDMENT TO LEASE WITH CIVIC CENTER ASSOCIATES FOR EXPANSION OF THE CITY'S COMMUNITY SERVICES DEPARTMENT.

WHEREAS, the City and Civic Center Associates have negotiated a Fifth Amendment to Lease at the intitial rental rate of \$4,333.50 per month, the fair market rate as determined by City valuation staff; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is authorized to execute, for and on behalf of The City of San Diego, a Fifth Amendment to Lease with the Civic Center Associates for the Community Services Department which is expanding into approximately 3,210 square feet on the 13th floor of the Civic Center Plaza Building, at an initial annual rent of \$4,333.50 per month, for a term of approximately 15 years commencing October 5, 1999, and terminating on July 23, 2014 (the expiration date of the Master Lease), under the terms and conditions set forth in that amendment to lease agreement on file in the office of the City Clerk as Document No. OO-

Section 2. That the City Auditor and Comptroller is authorized to expend an amount not to exceed \$38,442.33 from the General Fund 100, Department 042 for FY 2000 budget.

Section 3. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
