

ORDINANCE NUMBER O- 18729 (NEW SERIES)

ADOPTED ON DEC 06 1999

AN ORDINANCE AMENDING CHAPTER 5, ARTICLE 9, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 59.0102 AND 59.0104 RELATING TO ENTRY INTO QUALCOMM STADIUM PARKING LOT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter 5, Article 9, Division 1, of the San Diego Municipal Code be and the same is hereby amended by amending Section 59.0102 and Section 59.0104 to read as follows:

SEC. 59.0102 Definitions

(a) - (k) No change in text.

(l) Overflow Capacity Event shall mean any event in the QUALCOMM Stadium in which attendance is anticipated to be in excess of sixty thousand (60,000) people and in which a use or occupancy permit has been issued for the use of the Stadium facility only, and not for the use of both the Stadium and the Stadium Parking Facility.

(m) - (n) No change in text.

SEC. 59.0104 Activities Prohibited within the QUALCOMM Stadium Parking Facility

(a) - (d) No change in text.

(e) No person shall bring or attempt to bring a vehicle into QUALCOMM Stadium Parking Facility without paying the prescribed charge required for admission.


On the day of, during, and for eight (8) hours after any event duly designated by the City Manager as an "Overflow Capacity Event," no person shall enter or attempt to enter QUALCOMM Stadium Parking Facility without presenting a valid ticket or pass to that event, or a pass indicating that the person is an on-duty employee working the event, or a control number for that event issued by the San Diego Police Department pursuant to the QUALCOMM Stadium policy governing distribution of non-commercial literature in the Stadium Parking Facility during such events; provided, however, that notices of such prohibition shall be duly posted at least twenty-four (24) hours prior to the event and remain posted throughout the event and the eight (8) hour period thereafter.

(f) - (l) No change in text.

Section 2. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

SEC. 59.0102 Definitions

(a) - (k) No change in text.

(l) Overflow Capacity Event shall mean any event in the QUALCOMM Stadium in which attendance is anticipated to be in excess of ~~fifty-five thousand (55,000)~~ sixty thousand (60,000) people and in which a use or occupancy permit has been issued for the use of the Stadium facility only, and not for the use of both the Stadium and the Stadium Parking Facility.

(m) - (n) No change in text.

SEC. 59.0104 Activities Prohibited within the QUALCOMM Stadium Parking Facility

(a) - (d) No change in text.

(e) No person shall bring or attempt to bring a vehicle into QUALCOMM Stadium Parking Facility without paying the prescribed charge required for admission. On the day of, during, and for eight (8) hours after any event duly designated by the City Manager as an "Overflow Capacity Event," no person shall enter or attempt to enter QUALCOMM Stadium Parking Facility without

presenting a valid ticket or pass to that event, or a pass indicating that the person is an on-duty employee working the event, or a control number for that event issued by the San Diego Police Department pursuant to the QUALCOMM Stadium policy governing distribution of non-commercial literature in the Stadium Parking Facility during such events; provided, however, that notices of such prohibition shall be duly posted at least twenty-four (24) hours prior to the event and remain posted throughout the event and the eight (8) hour period thereafter.
