WHEREAS, they discussed the roles of the police, prosecutors, defense attorneys, witnesses, judges, and jurors; and

WHEREAS, the students also took part in the mock trial of "Goldie Locke," who was accused of breaking into the Brown family home without the Browns' permission, eating their food, and sleeping in Baby Brown's room; and


WHEREAS, by educating elementary school students about the criminal justice system, the Juveniles and Justice team works on both prevention and intervention; and
