A RESOLUTION ESTABLISHING AN UNDERGROUND UTILITY DISTRICT TO BE KNOWN AND DENOMINATED AS THE CCDC AREA 3 PHASE 1 (K STREET TO SOUTH 16TH STREET AND 12TH AVENUE TO 17TH STREET) UNDERGROUND UTILITY DISTRICT.

WHEREAS, notice of such hearing has been given by the City Clerk to all affected property owners as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and the utilities concerned in the manner and for the time required by law; and

WHEREAS, such hearing has been duly and regularly held and all persons interested have been given an opportunity to be heard; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. The City Council hereby finds and determines that the public health, safety, or general welfare require the removal of poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within the area set forth above and that pursuant to Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, the above area is hereby declared to be an underground utility district in the City of San Diego, and the maps and document referred to above are hereby incorporated as a part of this resolution.
- 2. The City Council shall by subsequent resolution fix the date on which the property in the district must be ready to receive underground service, and shall by subsequent resolution order the removal of all poles, overhead wires, and associated overhead structures, and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service.
- 3. The City Clerk is hereby instructed to notify all affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and all affected utility companies of the adoption of this resolution within fifteen days after date of adoption. The City Clerk shall further notify affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code of the necessity that if they desire to continue to receive electric, communication, community antenna television or similar or associated service they shall provide at their own expense all the necessary facility changes on their premises so as to receive underground service from the lines relocated underground of the supplying utility company subject to applicable rules,

regulations, and tariffs of the respective utility company on file with the Public Utilities Commission of the State of California (as of the date of adoption of this resolution) and subject to all other applicable requirements of State law and City ordinances. The Clerk's notification shall be made in the manner provided in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code.

13TH STREET between the southerly line of K STREET and a line parallel to and 150 feet south of the southerly line of COMMERCIAL STREET;

14TH STREET between the southerly line of K STREET and a line parallel to and 140 feet south of the southerly line of COMMERCIAL STREET;

15TH STREET between the southerly line of K STREET and a line parallel to and 130 feet south of the southerly line of COMMERCIAL STREET;

16TH STREET between the southerly line of K STREET and the southerly line of NEWTON AVENUE;

17TH STREET between a line parallel to and 300 feet north of the northerly line of IMPERIAL AVENUE and a line parallel to and 250 feet south of the southerly line of COMMERCIAL STREET;

NATIONAL AVENUE between the southerly line of IMPERIAL AVENUE and the southerly line of S 16th STREET;

<u>NEWTON AVENUE</u> between a line parallel to and 740 feet north westerly of the northerly line of S 16TH STREET and the northerly line of SIGSBEE STREET.
