A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN  
DIEGO RATIFYING THE ELECTION RESULTS OF  
FEBRUARY 9, 1999, FOR THE PROJECT AREA COMMITTEE  
FOR THE NORTH PARK REDEVELOPMENT PROJECT  
AREA.

WHEREAS, the Council of The City of San Diego [the Council] by Resolution No. R-276720, adopted the Procedure of the Formation of a Project Area Committee [PAC] for the North Park Redevelopment Project Area Committee at its October 16, 1990, meeting; and

WHEREAS, on January 15, 1991, the Council by Resolution No. R-277220 approved the PAC representatives initially elected to the PAC; and

WHEREAS, since the initial election of PAC members, vacancies have occurred on the PAC; and

WHEREAS, after notice was given in accordance with the PAC bylaws, an election of the PAC was conducted on February 9, 1999; and

WHEREAS, a challenge to the election has been filed by April Fleck; and

WHEREAS, this Council, having heard and considered the facts presented by both Ms. Fleck and City staff, is satisfied that the election was held according to the PAC bylaws and established procedures enumerated within the documents approved by the Council; and

WHEREAS, a representative from the City Clerk's Office attended the election to ensure its validity; and

WHEREAS, the newly elected members of the PAC have submitted to this Council information establishing the qualifications of each person relative to district, category, or organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council finds that the challenge to the election is rejected and that all procedures adopted by Resolution No. R-276720 were followed in the election.
2. That the persons elected as members of the North Park Redevelopment Project Area Committee, as noted by the City Clerk's verification of the election results of February 9, 1999, attached hereto as Exhibit A and incorporated herein by this reference, are approved as the newly elected members to the PAC.
3. That the Council concurs that the election results of February 9, 1999, are valid and binding in accordance with the procedures so adopted by Resolution No. R-276720.
4. That the Redevelopment Agency of The City of San Diego is directed to consult with and obtain the advice of the PAC pursuant to the provisions of the California Community Redevelopment Law (California Health and Safety Code section 33000 et seq.)


