BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the CONSTRUCTION OF MISSION BAY SHORELINE PROTECTION PHASE III, filed in the office of the City Clerk of The City of San Diego California, on MAR 23 1999, and bearing official Document No. W.O. 218582 be and the same are hereby approved.


2. That the Contract Services Division of The City of San Diego be, and is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the CONSTRUCTION OF MISSION BAY SHORELINE PROTECTION PHASE III.

4. That the expenditure of an amount not to exceed \$1,600,000 from C.I.P. No. 21-834.0, Balboa Park/Mission Bay Park Improvement Program Fund No. 91106, is authorized for said project and related costs, provided that the City Auditor first furnishes a certificate demonstrating that the funds necessary for such expenditure are, or will be, on deposit in the City Treasury.

5. That the City Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves:
