- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the ENCANTO STANDPIPE DEMOLITION.
- 4. That the City Auditor and Comptroller is hereby authorized to transfer \$100,000 from Water Fund 41500, CIP No. 73-249.0, 'South San Diego Pipeline No. 2' to CIP 73-277.0, Annual Allocation Standpipe and Reservoir.
- 5. That the expenditure, not to exceed \$466,331 from Water Fund 41500, CIP No. 73-277.0 AA-Standpipe and Reservoir is hereby authorized, solely and exclusively for the purpose of providing funds for said project and related costs, provided that the City Auditor first

furnishes a certificate demonstrating that the funds necessary for the expenditure are, or will be, on deposit in the City Treasury, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
