BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$250,000 from Fund No. 41500, CIP 75-929.0, Reclaimed Water Beneficial Reuse Study, is hereby authorized, solely and exclusively to provide funds for investigating alternatives to the water repurification project.
