## EXHIBIT A

### MITIGATION MONITORING AND REPORTING PROGRAM

Sewer Group Job 647.

(LDR No. 99-0018)

This Mitigation Monitoring and Reporting Program is designed to ensure compliance with Public Resources Code Section 21081.6 during implementation of mitigation measures. This program identifies at a minimum: the department responsible for the monitoring, what is to be monitored, how the monitoring shall be accomplished, the monitoring and reporting schedule, and completion requirements. A record of the Mitigation Monitoring and Reporting Program will be maintained at the offices of the Land Development Review, 1222 First Avenue, Fifth Floor, San Diego, CA 92101. All mitigation measures contained in the Mitigated Negative Declaration (LDR No. 99-0018) shall be included in the Project Plans and Specifications. The City of San Diego, Engineering and Capital Projects Department and Planning and Development Review Department are jointly responsible for ensuring that the following program is carried out.

#### MITIGATION, MONITORING AND REPORTING PROGRAM:

##### Cultural Resources:

1. Prior to the start of construction, the Engineering and Capital Projects Department Project Manager shall provide verification that a qualified archaeologist and / or an archaeological monitor, have been retained to implement the archaeological monitoring program. This verification shall be in the form of a letter from the Project Manager of the Environmental Analysis Section (EAS) of the Planning and Development Review Department.

A qualified archaeologist is defined as an individual certified by the Society of Professional Archaeologists (SOPA). At least 200 hours of field experience required for certification must have been obtain in southern California. Uncertified individuals who believe they meet the requirements for certification may submit evidence of their qualifications to the Planning and Development Review Department.

An archaeological monitor is defined as an individual who has expertise in the collection and salvage of cultural resources and who is working under the direction of a qualified archaeologist.

**ALL PERSONS INVOLVED IN THE ARCHAEOLOGICAL MONITORING OF THIS PROJECT SHALL BE APPROVED BY EAS AT LEAST 30 DAYS PRIOR TO THE PRECONSTRUCTION MEETING.**

2. The qualified archaeologist shall attend any preconstruction meetings to make comments and / or suggestions concerning the monitoring program

and to discuss excavation plans with the excavation contractor. The requirements for archaeological monitoring shall be noted on the construction plans. The archaeologist's duties shall include monitoring, evaluation, analysis of collected materials, and preparation of a monitoring results report in conformance with the City's Guidelines for the Determination of the Significance of Archaeological Sites. These duties are defined as follows:

a. **Monitoring:**

The qualified archaeologist or archaeological monitor shall be present on site during construction activity involving only NEW AND / OR DEEPER EXCAVATION work the in previously undisturbed soils. This would include all sections of the project, they are as follows:

- Sheet 2 NORTH TALMADGE DR.
- Sheet 3 WEST TALMADGE DR.
- Sheet 4 EAST TALMADGE DR. AND NORTH TALMADGE DR.
- Sheet 5 SHORT ST. AND EAST TALMADGE DR.
- Sheet 6 EAST TALMADGE DR.
- Sheet 7 WEST TALADGE DR.
- Sheet 8 MADISON AVE.
- Sheet 9 VAN DYKE AVE.

In short, any new trenching of undisturbed soil requires monitoring by a qualified person outlined in the earlier discussion.

b. **Evaluation**

In the event that cultural resources are discovered, the archaeologist with the concurrence of the resident engineer, shall have the authority to divert or temporarily halt ground disturbance operations in the area of discovery to allow evaluation of potentially significant cultural resources. **THE ARCHAEOLOGIST SHALL CONTACT EAS AT THE TIME OF DISCOVERY.** The significance of the discovered resources shall be determined by an archaeologist, in consultation with EAS. EAS must concur with the evaluation procedures to be performed before construction activities are allowed to resume. For significant

cultural resources, a Research Design and Data Recovery Program shall be prepared and carried out to mitigate impacts. Any human bones of Native American origin shall be turned over to the appropriate Native American group for reburial.

c. Analysis

All collected cultural remains shall be cleaned, cataloged and permanently curated with an appropriate installation. All artifacts shall be analyzed to identify function and chronology as they relate to the history of the area. Faunal material shall be identified as to species. Specialty studies shall be completed as appropriate.

d. Report Preparation

A monitoring results report with appropriate graphics, which describes the results, analysis, and conclusions of the above program shall be prepared and submitted to EAS within three months following termination of the cultural resources program. Also, any sites or features encountered shall be recorded with the South Coastal Information Center at San Diego State University and with San Diego Museum of Man .

**THE PROJECT MANAGER SHALL NOTIFY EAS STAFF OF ANY PRECONSTRUCTION MEETING DATES AND OF THE START AND END OF CONSTRUCTION.**

Implementation of the above measures will reduce impacts to cultural resources resulting from construction of this project to below a level of significance.

Paleontological Resources:

1. Prior to construction activities, the Engineering and Capital Projects Department Project Manager shall provide verification that a qualified paleontologist and / or paleontologist monitor has been retained to implement the paleontological monitoring program. This verification shall be in the form of a letter from the Project Manager to the Principal Planner of the Environmental Analysis Section (EAS), of the Planning and Development Review.

A qualified paleontologist is defined as an individual with a Ph.D. or M.S. degree in paleontology or geology who is a recognized expert in the application of paleontological procedures and techniques such as screen washing of materials and identification of fossil deposits, and who has field experience in southern California.

A paleontological monitor is defined as an individual who has experience in the collection and salvage of fossil material and who is working under the direction of a qualified paleontologist.

**ALL PERSONS INVOLVED IN THE PALEONTOLOGICAL MONITORING OF THIS PROJECT SHALL BE APPROVED BY EAS AT LEAST 30 DAYS PRIOR TO THE PRECONSTRUCTION MEETING.**

2. The qualified paleontologist shall attend any preconstruction meetings to consult with the excavation contractor and to make comments and /or suggestions concerning the monitoring program. The paleontologist's duties shall include monitoring, salvaging, preparation of materials for deposit in a local scientific institution that houses paleontological collections, and preparation of a monitoring report. These duties are defined as follows:

a. Monitoring

The Paleontologist or paleontological monitor shall be on site during all excavation activities in previously undisturbed Geological formations which underlain by Lindavista Formation (Qln), that may contain fossilized materials identified in the Initial Study. This include all segments of the of this sewer group. They are as follows:

- Sheet 2 NORTH TALMADGE DR.
- Sheet 3 WEST TALMADGE DR.
- Sheet 4 EAST TALMADGE DR.
- Sheet 5 SHORT STREET AND EAST TALMADGE DR.
- Sheet 6 EAST TALMADGE DR.
- Sheet 7 WEST TALMADGE DR.
- Sheet 8 MADISON AVE.
- Sheet 9 VAN DYKE AVE.

In short, any new trenching requires monitoring by a qualified person outlined in the earlier discussion.

b. Salvaging

In the event that well-preserved fossils are found, the paleontologist shall have the authority to divert, direct, or temporarily halt construction activities in the area of discovery to allow recovery of fossil remains in a

timely fashion. Recovery is anticipated to take from one hour to a maximum of two days. THE PALEONTOLOGIST SHALL CONTACT EAS AT THE TIME DISCOVERY. EAS must concur with salvaging methods before construction activities are allowed to resume.

c. Fossil Preparation

Fossil remains shall be cleaned, sorted, catalogued, and then deposited in a local scientific institution that houses paleontological collections ( such as the San Diego Natural History Museum).

d. Report Preparation

A monitoring results report, with appropriate graphics, which summarizes the results, analysis, and conclusions of the above monitoring program shall be prepared and submitted to EAS within three months following the termination of the paleontological monitoring program.

**THE PROJECT MANAGER SHALL NOTIFY EAS STAFF OF ANY PRECONSTRUCTION MEETING DATES AND OF THE START AND END OF CONSTRUCTION.**

Implementation of the above measures would reduce impacts to fossil resources resulting from construction of this project, to below a level of significance.
