BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and hereby is authorized and empowered to execute, for and on behalf of said City, the agreement with RELIASTAR LIFE INSURANCE COMPANY, for group life and accidental and dismemberment insurance, a copy of which is on file in the office of the City Clerk as Document No. RR- 291672, to extend the agreement for a two-year period beginning July 1, 1998 through June 30, 2000, and to authorize the monthly premium rate at \$0.16 per thousand.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$782,018 from Fund 60026, Account No. 9544, is hereby authorized solely and exclusively for the purpose of providing funds for the execution of the above agreement.
