


RESOLUTION NUMBER R- 291675

ADOPTED ON MAY 24 1999

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and hereby is authorized and empowered to execute, for and on behalf of said City, an agreement with HEALTH NET SENIORITY PLUS, to provide group health insurance to Medicare eligible retirees, a copy of which is on file in the office of the City Clerk as Document No. RR- 291675, to extend coverage under the agreement for a one-year period beginning August 1, 1998 through July 31, 1999, and to authorize the monthly premium rate of \$32.15 per member.

BE IT FURTHER RESOLVED that the expenditure of an amount not to exceed \$92,206 from Fund 60077, Account 9544, is hereby authorized solely and exclusively for the purpose of providing funds for the execution of the above agreement.
