A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO APPROVING A REPRESENTATIVE PROJECT
AREA COMMITTEE FOR THE BARRIO LOGAN
REDEVELOPMENT PROJECT AREA.

WHEREAS, the Council of The City of San Diego by Resolution No. R-274651, adopted the Procedure for the Formation of Project Area Committee for the Barrio Logan Redevelopment Project (referred to in that document as the Mercado del Barrio Redevelopment Project) at its October 30, 1989, meeting; and

WHEREAS, an election was conducted on March 17, 1999, after notice and according to established procedures enumerated within the documents approved by the City Council; and

WHEREAS, a representative from the City Clerk's Office attended the election to ensure its validity; and

WHEREAS, the elected members of the Project Area Committee have submitted to this City Council information establishing the qualifications of each person relative to district, category or organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Barrio Logan Redevelopment Project Area Committee consisting of persons named on the list of Project Area Committee members receiving the highest number of votes attached hereto as Exhibit A and incorporated herein by this reference is hereby approved as constituting a representative Project Area Committee.

3. That the Redevelopment Agency of the City of San Diego is hereby directed to consult with and obtain the advice of the Project Area Committee concerning those policy matters which deal with the planning and provision of residential facilities or replacement housing and other matters which affect the residents of the Project Area pursuant to the provisions of the California Redevelopment Community Law [California Health and Safety Code section 33000 et seq.).
