RESOLUTION TO LEVY AND COLLECT FISCAL YEAR 1999-2000 ANNUAL ASSESSMENTS ON KINGS ROW MAINTENANCE ASSESSMENT DISTRICT.

DESCRIPTION OF MAINTENANCE DISTRICT

All that real property in the City of San Diego included within the exterior boundary lines

BE IT FURTHER RESOLVED, that the District is described as follows:

Section 3

ASSESSMENT OF COST AND EXPENSE

BE IT FURTHER RESOLVED, that the maintenance and expense of the contemplated maintenance are made chargeable upon the District, and the Council does declare that certain properties within the District receive special benefit from the maintenance of the improvements.

BE IT FURTHER RESOLVED, that the City Council proposes to assess those properties within the District which receive a special benefit from the maintenance for the total amount of the maintenance costs of the District, plus incidental expenses thereto, to be received by the individual parcels of real property within the District.

BE IT FURTHER RESOLVED, that the Council may order a portion of the costs of maintenance to be paid by the City from appropriate funds. The proposed budget for the District is as follows:
