

RESOLUTION NUMBER R- 291847

ADOPTED ON JUN 28 1999

WHEREAS, the City of San Diego received a grant from the California Department of Traffic Safety (OTS) for a program called Safe Communities-2000, which was approved by Council in Document #289369, a copy of which is on file in the Office of the City Clerk; and

WHEREAS, the City entered into an agreement with Louise Nichols to serve as Program Assistant of Safe Communities-2000 in Document Number 289371-2, a copy of which is on file in the Office of the City Clerk; and

WHEREAS, OTS has increased funding for the Safe Communities-2000 program, and approved a salary increase for Consultant; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to execute the Amendment to the Agreement with consultant Louise Nichols, Program Assistant, of the San Diego Safe Communities-2000 grant project;

BE IT FURTHER RESOLVED, that Council hereby authorizes the City Manager to execute said agreement, and that this authority shall include all aspects of operations and expenditures, under the terms and conditions of the approved grant program proposal and the Agreement, including any amendments or extensions thereof for a period of up to five years, providing OTS makes funding available for this or an essentially identical program, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said documents and processes;

BE IT FURTHER RESOLVED, that any funds received under this grant shall not be used to supplant expenditures controlled by this body;

BE IT FURTHER RESOLVED, that personnel and/or consultant positions funded by this grant award are not subject to local hiring freezes.
