- 2. That the Contracts Services Division of The City of San Diego be, and is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the DEERFIELD WATER PUMP PLANT AND TRANSMISSION PIPELINES.
- 4. That the expenditure of an amount not to exceed \$6,164,214 from CIP No. 73-268.0 Deerfield Water Pump Plant, Water Revenue Fund No. 41500 and an amount not to exceed \$336,000 from CIP No. 73-331.0, Annual Allocation for Pooled Contingency, Water Revenue Fund No. 41500, is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, provided that the City Auditor and Comptroller first furnishes a

certificate demonstrating that the funds necessary for such expenditure are or will be on deposit in the City Treasury.

- 5. That City Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
- 6. That the City Manager is authorized to enter into an agreement with John Powell & Associates to provide Engineering design support during the construction of the DEERFIELD WATER PUMP PLANT AND TRANSMISSION PIPELINES at a cost not to exceed \$151,756.
