

RESOLUTION NUMBER R-291912

ADOPTED ON JULY 19, 1999

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO WITHDRAWING RECOGNITION OF THE SOUTHEAST SAN DIEGO DEVELOPMENT COMMITTEE FOR A PORTION OF THE COMMUNITY PLANNING AREA AND RECOGNIZING THE ENCANTO NEIGHBORHOODS COMMUNITY PLANNING GROUP.

WHEREAS, it is the policy of the City to recognize community planning committees to advise the City Council, Planning Commission, and the City Manager in the preparation, adoption of, implementation of, or amendment to the General Plan or community plan as it pertains to the area of concern of each committee; and

WHEREAS, the community planning group presently recognized by the City in the Southeastern San Diego Community Plan Area, the Southeast San Diego Development Committee, has the largest geographic area of responsibility of any community planning group in the City of San Diego; and

WHEREAS, the geographic area of responsibility for the Southeast San Diego Development Committee is comprised of diverse, independent, and autonomous neighborhoods making it extremely difficult for this community planning group to adequately represent the interests of the area as a whole; and

WHEREAS, in the past, for example in the Mid-City Community Plan Area, the City has recognized several community planning committees within a single community plan area in order to promote efficiency in the planning process; and

WHEREAS, the planning area proposed for the Encanto Neighborhoods Community Planning Group has historically had little or no representation on the Southeast San Diego Development Committee; and

WHEREAS, this action will promote more focused and efficient citizen involvement and allow the new planning group a greater voice in the planning process; and

WHEREAS, this action will facilitate growth and economic development within both the Encanto Neighborhoods and the remaining area represented by the Southeast San Diego Development Committee by promoting more efficient review and advice to the City on projects and future development within the Southeastern San Diego Community Plan Area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That recognition of the Southeast San Diego Development Committee is withdrawn for a geographic portion of the Southeastern San Diego Community Plan Area as reflected on Attachment 1, hereby incorporated by reference as a part of this resolution.
2. That a new community planning committee for the Southeastern San Diego Community Planning Area is established and recognized as the Encanto Neighborhoods Community Planning Group with responsibility for the geographic portion of the Southeastern San Diego Community Plan Area as reflected on Attachment 1.
3. That the Encanto Neighborhoods Community Planning Group Bylaws, initial membership and terms, are approved as being in conformance with City Council Policy 600-24; a copy of which is on file in the office of the City Clerk as Document No. RR-291912.

4. That the City Council approves the initial membership to the Encanto Neighborhoods Community Planning Group as set out in Attachment 2, which is attached hereto and incorporated herein by this reference.

5. That the Southeast San Diego Development Committee is directed to process conforming amendments to its Bylaws to remove the geographic area now under the responsibility of the Encanto Neighborhoods Community Planning Group and, if the group so desires, to reduce the committee membership to a more manageable number from 20 to 16.

6. That the City Manager and City Attorney are hereby authorized to review and approve the conforming amendments to the Southeast San Diego Development Committee Bylaws as described above in paragraph 4.

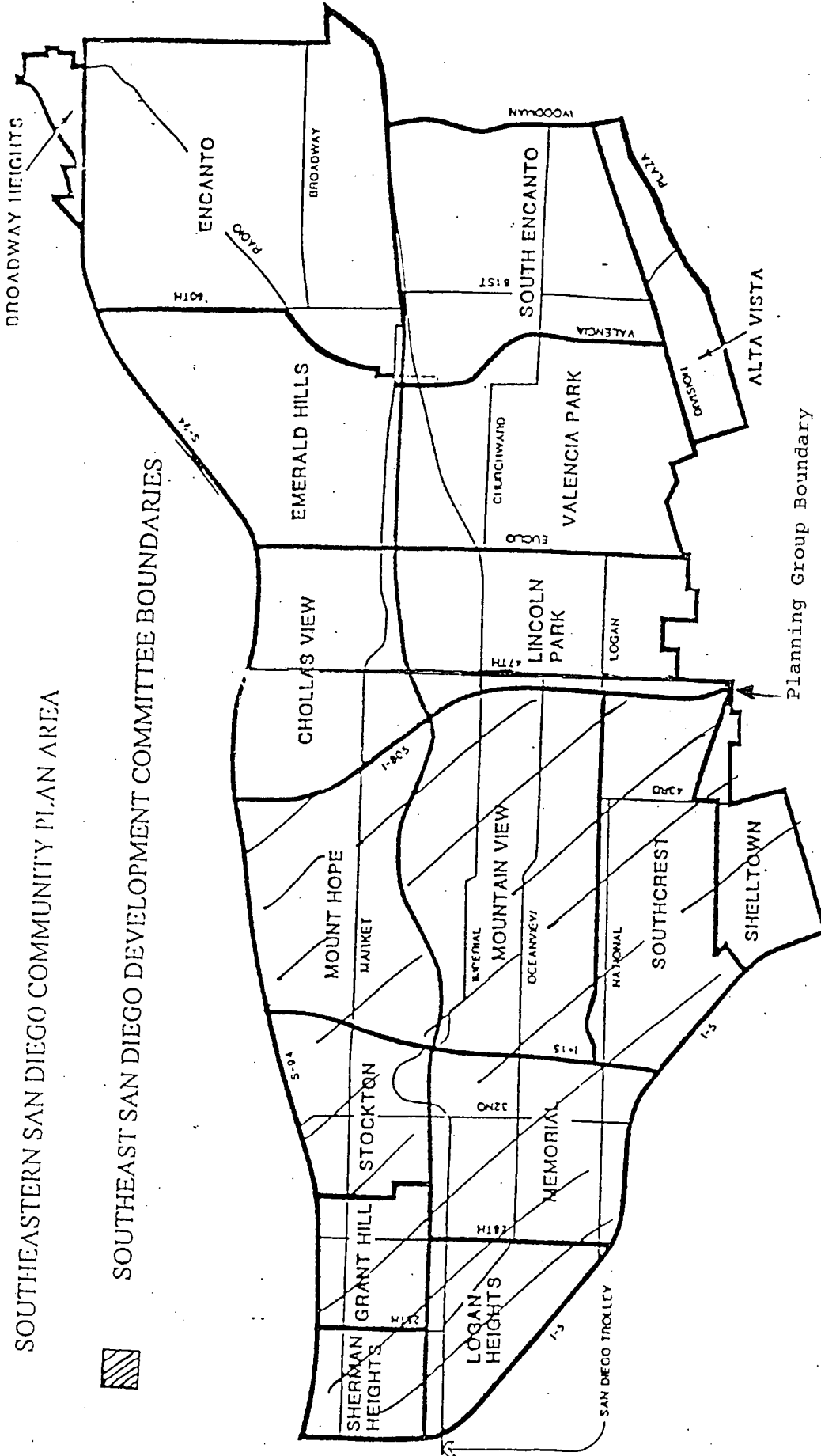

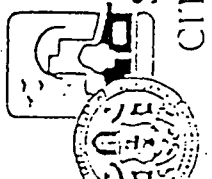

SOUTHEAST SAN DIEGO DEVELOPMENT COMMITTEE BOUNDARIES

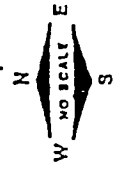
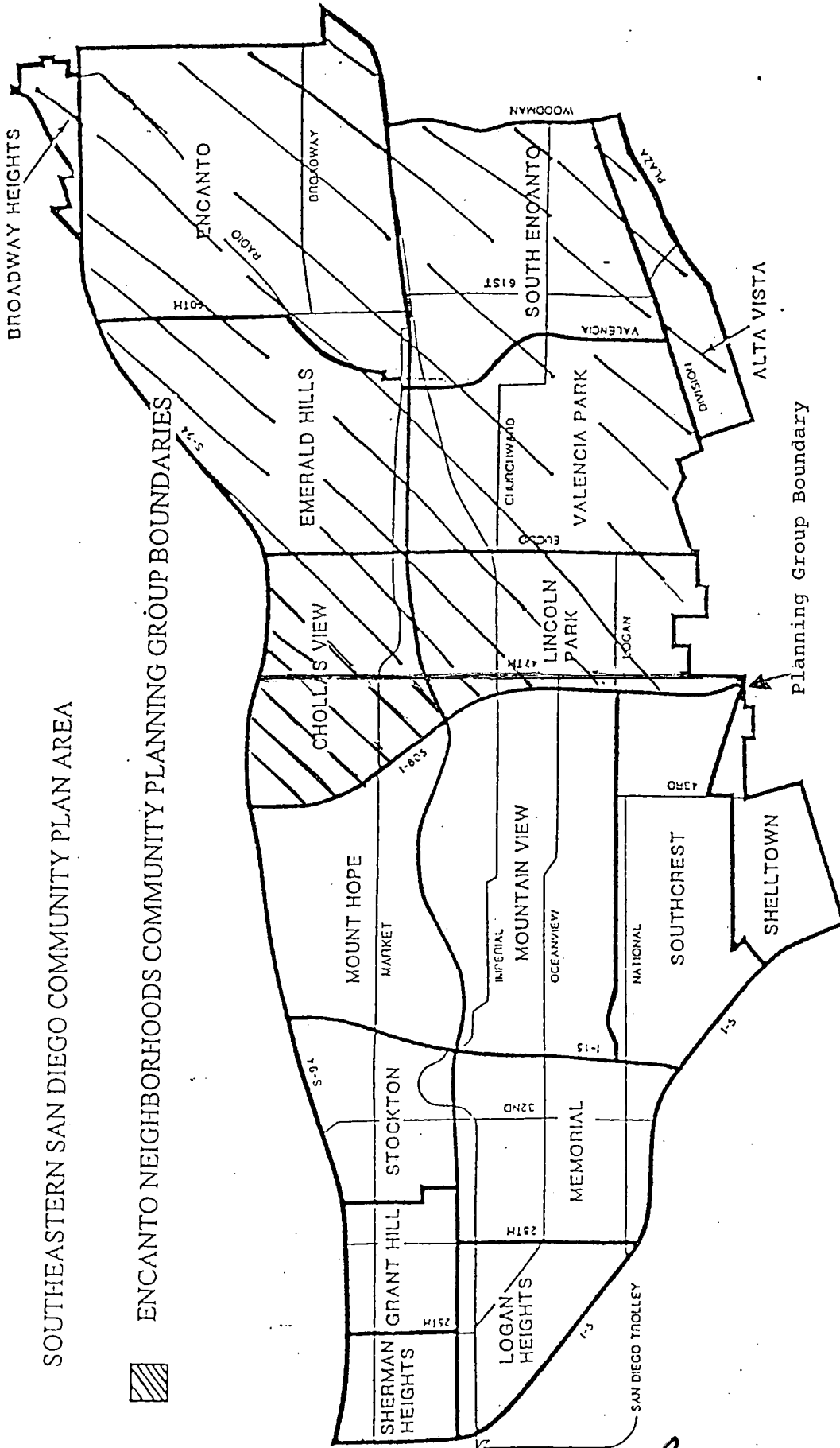
