- 3. That the City Manager is hereby authorized to establish contract funding phases and to execute a contract with the lowest responsible bidder for the CONSTRUCTION OF HOME AVENUE TRUNK SEWER, CONTRACT III. provided that the City Auditor first furnishes a certificate demonstrating that the funds necessary for such expenditure are, or will be, on deposit in the City Treasury.

- 4. That the City Auditor and Comptroller is hereby authorized to transfer \$635,377 from Sewer Fund 41506, CIP No. 46-106.0, Annual Allocation-Sewer Pump Station Rehabilitation to Sewer Fund 41506, CIP No. 46-139.2, Home Avenue Trunk Sewer Contract III for the purpose of funding said project.
- 5. That the expenditure, not to exceed \$4,669,750 from Fund 41506, CIP No. 46-139.2 is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for such expenditure are or will be on deposit in the City Treasury.
- 6. That the City Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
