BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized and empowered to execute, for and on behalf of said City, a Grant Agreement with the Department of Housing and Urban Development [HUD], for 1999 EDI Special Project

No. B-99-SP-CA-0060 for the Urban Village Commercial Project, under the terms and conditions set forth in the Grant Agreement on file in the office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the City Council accepts the \$400,000 EDI grant from HUD, amends the City budget, and authorizes the transfer of the \$400,000 EDI grant to the Agency.

BE IT FURTHER RESOLVED, that approval of this budget amendment constitutes authority for expenditure of the funds by the Redevelopment Division of the City's Economic Development and Community Services Department in Fiscal Year 1998-1999.
