WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets and public service easements by City Council resolution where the portion of the street to be vacated is excess to the City's right-of-way needs and is no longer required for street or highway purposes; and

WHEREAS, the adjacent property owner has requested the vacation of a portion of 33rd Street and alleys to unencumber this property and facilitate development of the site; and WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the street and alleys, either for the public street system for which the right-of-way was originally acquired, or for any other public use of a like nature that can be anticipated in that the right-of-way is not needed for public street, bikeway, or open space purposes; and
- (b) those properties adjoining the street and alleys to be vacated will continue to have access; and
 - (c) the public will benefit from the vacation through improved utilization of land; and
- (d) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (e) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That 33rd Street south of Webster Avenue and alleys in Block 2 of J.H. Orcutt's Subdivision of Central Homestead, as more particularly shown on Drawing No. 00016-1-C marked as Exhibit "B", and described in the legal description marked as Exhibit "A", both of which are attached hereto and made a part hereof, are ordered vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, with drawing and exhibit, to be recorded in the office of the County Recorder.


