

RESOLUTION NUMBER R- 292032

ADOPTED ON AUG 02 1999

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with P & D Consultants for engineering consultant services for the Belt Street Trunk Sewer Project, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 292032, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$181,912 from Sewer Fund 41506, CIP No. 46-111.0, Rose Canyon Trunk Sewer, and \$84,606 from Sewer Fund 41506, CIP No. 46-206.0, Annual Allocation - Emergency Construction, to Sewer Fund 41506, CIP No. 46-195.0, Belt Street Trunk Sewer.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$366,518 Sewer fund 41506, CIP No. 46-195.0, Belt Street Trunk Sewer, is hereby authorized, solely and exclusively for the purpose of providing funds for the design of Belt Street Trunk Sewer, provided that the City Auditor first furnishes a certificate certifying that funds are, or will be on deposit, with the City Treasurer.

BE IT FURTHER RESOLVED that the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


