
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ASL Consulting engineers to perform consultant services for the Sewer Pump Station 18 and 19 Rehabilitation/Replacement Project, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- **292037**, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$100,800 from Sewer Fund No. 41506, CIP No. 46-106.0, Sewer Pump Stations 18 and 19 Rehabilitation/Replacement, is hereby authorized, solely and exclusively for the purpose of providing funds for this agreement, provided that the City Auditor first furnishes a certificate certifying that funds are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED that the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
