BE IT FURTHER RESOLVED, that the appropriation and expenditure of funds to pay for consultant services in an amount not to exceed \$71,800 and to pay for City administrative costs in an amount not to exceed \$20,000 is authorized for the Cost Reimbursement District - Carmel Valley Neighborhood 10.
