
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Berryman & Henigar Consultants, Inc., for the design of La Jolla/ Pacific Beach Trunk Sewer-Chelsea Street Relocation, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 292209, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$558,258 from Sewer Fund 41506, CIP No. 46-215.0, Annual Allocation-Infrastructure Upgrade and Replacement to Sewer Fund 41506, CIP No. 46-194.0, Annual Allocation-Trunk Sewer Rehabilitation..

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$558,258 from Sewer Fund 41506, CIP No. 46-194.0, Annual Allocation-Trunk Sewer Rehabilitation, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED that the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
