BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and hereby is authorized and empowered to execute, for and on behalf of said City, an agreement with BLUE CROSS OF CALIFORNIA, to provide group health insurance, a copy of which is on file in the office of the City Clerk as Document No. RR- 292227, to extend coverage under the agreement for a one-year period beginning August 1, 1999 through July 31, 2000, and to authorize the premium rates.

BE IT FURTHER RESOLVED that the expenditure of an amount not to exceed \$5,542,186 from Fund 60020, Account 9544, is hereby authorized solely and exclusively for the purpose of providing funds for the execution of the above agreement.
