RESOLUTION NUMBER R- 292238 ADOPTED ON SEP 27 1999

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets and public service easements by City Council resolution where the portion of the street to be vacated is excess to the City's right-of-way needs and is no longer required for street or highway purposes; and

WHEREAS, the adjacent property owner has requested the vacation of a portion of Northside Drive and of certain public service easements to unencumber this property and facilitate development of the site; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the street and alleys, either for the public street system for which the right-of-way was originally acquired, or for any other public use of a like nature that can be anticipated in that the right-of-way is not needed for public street, bikeway, or open space purposes; and
- (b) those properties adjoining the street and alleys to be vacated will continue to have access; and
 - (c) the public will benefit from the vacation through improved utilization of land; and
- (d) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (e) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Northside Drive southeast of Friars Road, as shown on Drawing No. 19110-1-B, and described in the legal description marked as Exhibit "A", which are attached hereto and made a part hereof, is ordered vacated.
- 2. The drainage easement and building restricted easement, as shown on Drawing No. 19110-2-B, and described in the legal description marked as Exhibit "A-1", which are attached hereto and made a part hereof, are ordered vacated.
 - 3. That the resolution shall not become effective unless and until:
- (a) the City Engineer approves the proposed Parcel Map, (Tentantive Parcel Map 95-0544) for this site, including the dedication of a right-of-way for a cul-de-sac on Northside Drive; and
- (b) assurance is obtained through permit and bond, the construction of the cul-desac on Northside Drive as required by the City Engineer; and
- (c) the drainage system within the subject drainage easement is converted into a private drainage system maintained by the property owner as required by the City Engineer; and
- (d) the water and sewer facilities within the vacated portion of Northside Drive are relocated as required by the City Engineer.
- 3. That the City Engineer shall advise the City Clerk of the completion of the aforementioned conditions, and the City Clerk shall cause a certified copy of this resolution, with attachments, attested by him under seal, to be recorded in the office of the County Recorder.

4. In the event the above conditions are not completed within twelve months following the adoption of this resolution, then this resolution shall become void and be of no further force or effect.




