RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ACCEPTANCE OF AN ECONOMIC ADJUSTMENT GRANT FROM THE U.S. DEPARTMENT OF COMMERCE'S ECONOMIC DEVELOPMENT ADMINISTRATION.

WHEREAS, the Department of Commerce's Economic Development Administration has awarded a grant in the amount of \$100,000 to The City of San Diego to develop economic development strategies for the economic development component of the San Diego/Tijuana International Boundary Area Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager or his designee is hereby authorized and empowered, for and on behalf of The City of San Diego, to accept, appropriate, and expend grant funds from the U.S. Department of Commerce's Economic Development Administration in the amount of \$100,00 for the development of economic development strategies for the economic development component of the San Diego/Tijuana International Boundary Area Plan.
- 2. That in accordance with the terms of the above mentioned grant, it hereby authorized the City to provide a required match of \$100,000, and is paid for by in-kind services which will come from the budgets of the following departments: Transportation, Economic Development and Planning.
- 3. That the City Manager or his designee is hereby authorized and empowered to execute all documents, including but not limited to contracts, agreements, amendments, extensions,

renewals, or future funding, provided funding is made available by the U.S. Department of Commerce.

4. A copy of the grant award is on file in the Office of the City Clerk as Document No.
