AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING CHAPTER 10, ARTICLE 3, DIVISION 15, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 103 1514 RELATING TO PERMITTING LIVE/WORK QUARTERS IN THE MID-CITY COMMUNITIES PLANNED DISTRICT.

WHEREAS, the North Park Planning Committee, in the interest of commercial revitalization, supports an amendment to the Mid-City Communities Planned District to permit Live/Work Quarters in the North Park Commercial area; and

WHEREAS, on August 4, 1999, the Land Use and Housing Committee of the City

Council authorized staff to proceed with the preparation of an ordinance to permit Live/Work

Quarters in selected zones of the Mid-City Communities Planned District; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter 10, Article 3, Division 15 of the San Diego Municipal Code is amended by amending Section 103.1514 to read as follows:
