AN ORDINANCE OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING, CALLING, PROVIDING FOR AND GIVING NOTICE OF A SPECIAL ELECTION TO BE HELD IN COUNCIL DISTRICT 8 FOR THE PURPOSE OF FILLING A VACANCY IN THE OFFICE OF COUNCIL DISTRICT 8 IN THE CITY OF SAN DIEGO ON FEBRUARY 27, 2001.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. It is hereby ordered that a Special Election be held in Council District Eight (8) on Tuesday, February 27, 2001, for the purpose of filling a vacancy in the office of Councilmember for District 8, which vacancy is created by the resignation of the incumbent Councilmember.

Section 2. Under Charter section 12, if one candidate receives the majority of votes cast for all candidates in the special election, the candidate receiving the majority of votes cast shall be deemed to be and declared by the Council to be elected to the vacant office.

Section 3. Under Charter section 12, if no candidate receives a majority of votes cast in the special election, a special run-off election shall be held. The two candidates receiving the highest number of votes cast for the vacant seat in the first special election shall be the only candidates for the vacant Council seat and the names of only those two candidates shall be printed on the ballot for that seat.

Section 4. The person elected at the special election or at the special run-off election shall serve for the remainder of the unexpired term, that is, until December 2, 2002.

Section 5. The next regular Municipal Elections will be March 5, 2002 (the Primary Election for Council Districts 2, 4, 6 and 8), and November 5, 2002 (the General Election for Council Districts 2, 4, 6 and 8).

Section 6. For the purpose of the special election on February 27, 2001, the election precincts shall be the precincts established by the Board of Supervisors of the County of San Diego; provided, however, that certain precincts shall be consolidated in the manner indicated on the list of consolidated precincts on file in the office of the City Clerk.

Section 7. The City Clerk shall designate the polling places, and shall appoint the members of the precinct boards for the special election.

Section 8. The polls for the special election shall be open from 7:00 a.m. until 8:00 p.m. on Tuesday, February 27, 2001.

Section 9. The City Clerk is hereby directed to procure and supply the required number of ballots, sample ballots, equipment supplies and other printed matter.

Section 10. The following rates of compensation are hereby established for the special election.

Section 11. The City Clerk is hereby directed to cause this ordinance to be published once in the official newspaper of The City of San Diego.

Section 12. Pursuant to section 17 of the Charter of The City of San Diego, this ordinance shall take effect on the date of its adoption.
