

RESOLUTION NUMBER R- 292664

ADOPTED ON JAN 18 2000

WHEREAS, The City of San Diego, San Diego Police Department requires analysis of forensic alcohol and blood and urine toxicology; and

WHEREAS, the San Diego Police Department has neither the personnel nor the equipment necessary for such analysis; and

WHEREAS, to retain the utmost credibility, the analysis must be conducted at a facility licensed under Title 17, Chapter 2, Group 8, of the California Code of Regulations; and

WHEREAS, those individuals conducting the analysis must be available to testify in the County of San Diego; and

WHEREAS, the only properly licensed facility that is within 100 miles of San Diego and that is able to handle the routine volume of testing is Bio-Tox Laboratories in Riverside, California; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized to negotiate and execute a contract, a copy of which is on file with the City Clerk as Document No. RR- 292664, with Bio-Tox Laboratories for the analysis of forensic alcohol and blood and urine toxicology service for a one-year period from September 1, 1999, to

August 31, 2000, with options to renew for six additional one-year periods, to expend approximately \$280,000 annually, subject to appropriations.
