ADOPTED ON JAN 31 2000

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the Construction of Sewer Replacement Contract A2, filed in the office of the City Clerk of The City of San Diego, California, on JAN 31 2000, and bearing official Document No. W.O. 175741

be and the same are hereby approved.

2. That the Contract Services Division of The City of San Diego is authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

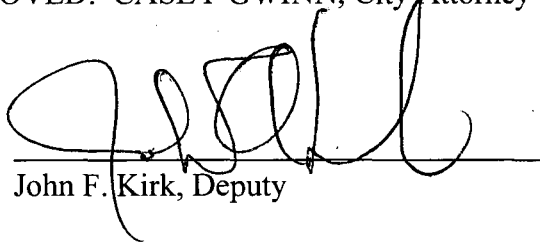
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the Construction of Sewer Replacement Contract A2.

4. That the City Auditor and Comptroller is hereby authorized to transfer \$1,625,600 from Sewer Fund 41506, CIP No. 44-001.0, Annual Allocation - Sewer Main Replacement to Sewer Fund 41506, CIP No. 46-206.0, Annual Allocation - Emergency and Accelerated Annual Allocation Projects.

5. That the expenditure, not to exceed \$1,625,600 from Sewer Fund 41506, CIP No. 46-206.0, is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for such expenditure are or will be on deposit in the City Treasury, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
