- 2. That the Contract Services Division of The City of San Diego is authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the Construction of Chollas Landfill Gas Upgrade.
- 4. That the City Auditor and Comptroller is hereby authorized to transfer \$60,000 from CIP 32-020.0 South Chollas Landfill Improvements, Fund No. 41201 to CIP 32-018.0, South Chollas Landfill Gas Upgrades.

5. That the expenditure of funds, not to exceed \$260,000 from CIP 32-018.0, South Chollas Landfill Gas Upgrades, Fund No. 41201, is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for such expenditure are or will be on deposit in the City Treasury, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
