BE IT RESOLVED, by the Council of The City of San Diego that the low bid of Villa Ford (Orange, CA), is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing Police Patrol Vehicles, as may be required for a period of one (1) year beginning February 1, 2000 through January 31, 2001, for a total estimated cost of \$2,779,172.99; terms 10% 30 days; with options to renew the contract for four (4) additional one (1) year periods, with price escalations not to exceed 5% of prices in effect at the end of each prior contract year.

BE IT FURTHER RESOLVED that the expenditure, not to exceed \$2,779,172.99, from Fund Nos. 100, 10117, and 18759, Department Nos. 110, 10117, and 18759, Organization No. 4001, Object Account No. 6013, and Job Order Nos. 004001, 010117, and 018759, is hereby authorized solely and exclusively for providing funds for said contract, and the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
