BE IT FURTHER RESOLVED, that the Council accepts on behalf of The City of San Diego, a municipal corporation, the easement designated as "Avigation Easement," in, through, and across all the airspace above elevation 684 feet MSL, over all the land, as granted and shown on the MAP and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the City Clerk is authorized and directed to endorse upon the MAP, as and for the act of the Council, that the Council has approved the MAP and that the streets are accepted on behalf of the public as stated in this resolution.

BE IT FURTHER RESOLVED, that the City Clerk is directed to transmit the MAP to the County Recorder of the County of San Diego, California.
