WHEREAS, Mr. Klein has served on the Pulitzer Prize Jury, has been a Director of the American Society of Newspaper Editors, and has been an active leader in the National Editorial Writers Association, The Associated Press Managing Editors' Organization, and United Press

International Editors; and

WHEREAS, Mr. Klein is a member of the executive committee of the San Diego Chamber of Commerce and the Economic Development Committee, a Kiwanis "fellow," an honorary Kiwanian in San Diego, and the author of *Making It Perfectly Clear*, a book acclaimed by critics for its hard-hitting definitive look at the love-hate relationship between the media and the Presidents; and
