WHEREAS, the Subcontracting Outreach Program would create subcontracting opportunities by requiring contractors on most City projects to subcontract a specified amount of the work on the project, to provide outreach and information for bidding and obtaining financing to subcontractors, and to negotiate in good faith with subcontractors; and

WHEREAS, the Subcontracting Outreach Program does not afford preferences to any group based on race, gender, color, ethnicity, or national origin, and as such does not violate Article 1, Section 31 of the California Constitution (Proposition 209); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized, on behalf of The City of San Diego, to adopt the proposed Subcontracting Outreach Program, in substantially the form that it appears in the attached document, with such changes as may be determined by the City Manager or his designee to best meet the objectives of the Program, subject to approval as to legality by the City Attorney.

BE IT FURTHER RESOLVED, that approximately \$65,620 from Fund No. 100,

Account No. 1100, in staffing expenses for fiscal year 2000 and the annual staffing expense of approximately \$262,482 commencing with fiscal year 2001, is hereby authorized and that the positions will be fully cost recoverable through various C.I.P. projects.
