A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE APPLICATION AND EXECUTION OF A GRANT FROM THE SAN DIEGO ASSOCIATION OF GOVERNMENTS COMPLETE COUNT COMMITTEE FOR STATE GRANT FUNDING FOR THE CITY'S CENSUS 2000 OUTREACH EFFORTS.

WHEREAS, The City of San Diego is interested in helping educate residents about the importance of the Census; and

WHEREAS, the City's Planning and Development Review Department has identified the need for funding of several outreach efforts which include: a poster drawing event for children at 52 Park and Recreation facilities, targeted mailings to specified undercounted census tracts, reproduction of Census videos for businesses and other agencies, and promotional items; and

WHEREAS, the Complete Count Committee of the San Diego Association of Governments [SANDAG] is making State grant funding available to local jurisdictions to help educate residents about the importance of the Census; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager, or designee, is authorized to apply to the SANDAG Complete Count Committee for State grant funding of the City's Census 2000 outreach efforts.

2. That the City Manager, or designee, is authorized to take all necessary steps to secure the State grant funds from SANDAG for the City's Census 200 outreach efforts.

3. That the City Manager, or designee, is authorized, for and on behalf of the City, to accept, appropriate, expend, and administer the grant funds, if the grant is awarded, in accordance with the terms and conditions set forth in the approved grant.

4. That the City Auditor and Comptroller is directed to establish a special interest bearing fund for the grant, if it is awarded.
