A RESOLUTION DECLARING THE RESULTS OF THE  
MUNICIPAL PRIMARY ELECTION HELD IN THE  
CITY OF SAN DIEGO ON MARCH 7, 2000.

WHEREAS, a municipal primary election was held in the City of San Diego on Tuesday, March 7, 2000, pursuant to the provisions of Ordinance No. O-18713 (New Series), for the purpose of nominating candidates and, if any candidate received a majority of all votes cast, for the purpose of electing that candidate; and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the municipal primary election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of this election has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.0411 of the San Diego Municipal Code, as follows:

I

The whole number of votes cast in the City was 292,904.


III
