A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE AMENDMENT OF THE REDEVELOPMENT AGENCY ANNUAL PROGRAM BUDGET PREVIOUSLY ADOPTED FOR FISCAL YEAR 1999-2000.

WHEREAS, the Redevelopment Agency of The City of San Diego [the Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Central Imperial Redevelopment Project Area [the Project Area]; and

WHEREAS, the Southeastern Economic Development Corporation [SEDC] has been authorized to administer the redevelopment projects in the Project Area; and

WHEREAS, Resolution Number R-287278 adopted by the Council of The City of San Diego on May 6, 1996; authorized repayment of an SEDC Section 108 loan of \$500,000 for a term of twenty years from CDBG allocations; and

WHEREAS, funds numbers 18532, 18533, 18534, and 18535 were established to facilitate the repayment of the 108 loan; and

WHEREAS, the Agency seeks to reprogram the money in these funds for the acquisition of property in the Central Imperial Redevelopment Project Area, and

WHEREAS, the Agency also seeks to amend the approved FY 99/00 Central Imperial Redevelopment Project Budget to include the monies from the proposed reprogram of CDBG funds in fund no. 98770 for acquisition and project implementation purposes, and

WHEREAS, in order to implement the various redevelopment projects, the Fiscal Year 1999-2000 Central Imperial Redevelopment Project Budget needs to be amended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That it approves reprograming of the balances of Community Development Block

Grant [CDBG] fund numbers 18532, 18533, 18534, and 18535 in the amount of \$1,291,010.99 from

Council District Four for acquisition of property in the Central Imperial Redevelopment Project.

2. That it approves the amendment of the FY 99/00 Central Imperial Redevelopment

Project Budget to include the monies from the proposed reprogram of CDBG funds in fund no. 98770

for acquisition and project implementation purposes.

3. That the Auditor and Comptroller is directed to record the unencumbered balances of

the above funds as an interest-bearing loan from The City of San Diego to be used in the Fiscal Year

1999-2000 SEDC Project Budget for acquisition and project implementation in the Central Imperial

Redevelopment Project Area.

4. That the Auditor and Comptroller is directed to record the balances of the above funds

as an interest-bearing loan to the Agency, to be paid as soon as practicable from tax increments on

other appropriate revenues.
